

On-Air Announcements:

KRWI (FM), Wofford Heights, CA:

On October 25, 2023, Rubin Broadcasting, Inc., licensee of KRWI (FM), 98.1 MHZ, Wofford Heights, filed an application with the Federal Communications Commission to assign its broadcast license to Kait and Danny Hill, d/b/a Hill Broadcasting. Members of the public wishing to view this application can visit publicfiles.fcc.gov and search for the KRWI (FM) public files, or those wishing to obtain information about how to file comments or petitions regarding the application can click on the Filing Comments/Petitions link at the same site.

- This message should be broadcast at least once per week (Monday through Friday) for four consecutive weeks, for a total of six (6) broadcasts, with no more than two broadcasts in a single week. Broadcasts made in the same week should not air on the same day.
- The first on-air announcement must air after and within 5 days following the date the FCC releases the formal acceptance public notice. **Note: we will try to catch this, but if not, just wait five days from the submission date and start.**
- The station should broadcast all on-air announcements between the hours of 7:00 a.m. and 11:00 p.m. Monday through Friday.
- If the station is broadcasting primarily in a foreign language, the announcements should be broadcast in that language.

Online Public Notice:

The licensee should post the following paragraphs on the new applications landing page of each Station's website. If the Stations do not have a website, the online public notice may be posted to the website of a parent or affiliated company, or if they do not have such a website, on some publicly accessible site (like a community bulletin board, local newspaper site, or that of a state broadcast association) and that link must link to another webpage (the "landing page") on which the specific text that the FCC now requires for public notice is displayed stating the following:

- These postings must commence after and within 5 days following date the FCC releases the formal acceptance public notice. **We will attempt to notify you of the date the FCC releases the formal acceptance notice, but in case we do not catch it, estimate a week from the date of submission to be safe and then run it a little longer than 30 days.**
- The online notices must be posted on the applications landing page for a **minimum of 30 consecutive days**. **Once the application has been granted, you can remove the posting.**
- Note that once the application is granted, you should change the text on the landing page to read: “There are no pending applications for the Station that are subject to the FCC’s Online Written Public Notice Requirement.”
- Also, you need to include on the landing page the date on which the page was last updated (and update as appropriate).

In the application, you have certified that you will comply with the above requirements. You do not have to do a follow-up certification, but it is always best to take and file a screen shot of the landing page reflecting your compliance.
